The major parts of the renovation project are on track to begin in September through February. We are currently working on the logistics of the project, from packing and moving our collection, notification and messaging to the public and continuation of patron services.

Library Director Tara Kohles has been working on the application for State Library Construction Aid. Suffolk County libraries receive approximately 2.5 million, and she is applying for funding for the upcoming project.

She has also started the process for the Library to earn the Sustainable Libraries certification. Currently fifteen other Suffolk County Libraries hold this certification. The upcoming renovation project is heavily focused on energy conservation, so it is excellent timing. The SLI program gives the Library a framework in which to make decisions on a wide variety of sustainability issues faced by libraries.
