## **DIRECTOR'S REPORT**

Ms. Kohles provided information to the Board regarding the proposed changes to the SCLS Resource Sharing Code. This provides standards that apply when patrons borrow materials from any other Suffolk County Library. The proposed change is that libraries will no longer continue to bill each other for lost items.

### **BUILDINGS & GROUNDS**

Many projects have been undertaken to improve the exterior appearance of the library:

- The chain link fence at the front of the property has been removed.
- Faded signage has been replaced.
- Crooked, damaged sign poles have been removed.

This has helped to create a more welcoming and appealing atmosphere for the patrons.

The Adult Computer Lab upgrade is complete, with seventeen new computers and monitors installed.

The installation of updated exterior security cameras has been completed.

The library has welcomed over twice the number of new patrons each month in comparison to last year. Ms. Kohles noted that is due to outreach efforts, excellent patron service and new program offerings.

Ms. Kohles has three hiring recommendations for the Board's Approval.

Island Harvest continues to distribute fresh vegetables from local farms at the library. Over 260 patrons per week are served through this program.

The Adult Reference Department was awarded the PLA/ALA Digital Literacy Incentive Grant of \$7,000. The librarians did an excellent job of writing the grant and received the highest amount.

The Central Islip Public Library will be hosting the Suffolk Cooperative Library System's Directors' meeting on March 16, 2023.

Sharon Dungee moved, seconded by Sharon Pedraza, to appoint Orlando Lopez III to the position of Senior Guard, at an hourly salary of \$25.00, effective September 28, 2022. All present voting aye, motion carried.
