## Budget Vote and Trustee Election April 9th, 9 AM – 9 PM Central Islip Public Library, 33 Hawthorne Ave, Central Islip NY 11722 The 2024/25 Operating Budget and Two Library Trustee Seats shall be voted on.

The Library will be undergoing major renovations starting in 2025. We will be creating new meeting rooms for the community, a new Teen Technology Center, Adult Reference Center and upgraded Computer Lab, and a Digital Media Center. In addition, a new HVAC system, solar panels and other energy upgrades will be made to make the Library more energy efficient.

The Library Board of Trustees has put forth a budget which provides for the Library to expand programs and services, add new technology, maintain and upgrade the building, and yet has a minimal impact on your Library taxes. This proposed budget increase is \$1.26 per month per household.

We hope you will visit your Library and our website often to take full advantage of all we have available for you and your family. Please remember to come out to vote on Tuesday, April 9th!

On January 31st 2024, The Central Islip Public Library Board of Trustees moved to adopt this budget within the New York State Tax Cap. This proposed budget is equivalent to a \$15.20 increase annually per household.
