The Library Board of Trustees has developed a budget that allows for increased programs and services and necessary improvements to the Library building, while having minimum impact on your library taxes. The Library Board of Trustees is proposing a budget for your consideration within the New York State Tax Cap of 2%. This will amount to an estimated increase of \$4.00 annually per household. You will be electing one Library Trustee this year for a five-year term. Library Trustee Luis Alcantara is the incumbent.

On January 29th 2025, The Central Islip Public Library Board of Trustees moved to adopt this budget within the New York State Tax Cap. This proposed budget is equivalent to a \$4 increase annually per household.
